DONATION FAQs

Why give to the United Way of Calhoun County and not directly to non-profit organizations?

A gift to the United Way of Calhoun County is an investment that benefits the entire community, not just one program, issue, or population. The United Way of Calhoun County provides an opportunity for your one gift to support a variety of local needs. Through one gift you can accomplish so much good!

Can I designate my gift to a specific partner agency?

Yes! If you would like to designate your gift, add a note/comment and include the non-profit's name.

How does my money stay in Calhoun County if some partner agencies are located outside of Calhoun County?

Every dollar raised is used locally. While some non-profit partner agencies are located outside of Calhoun County, funding is only used for programs that are provided specifically to Calhoun County residents. This allows for a more broad service range for Calhoun County residents.

How do I know my gift is used efficiently and effectively?

The United Way of Calhoun County annually vets each of its member non-profit organizations on a variety of criteria during their yearly grant application process. Non-profit organizations must be registered as a 501(c)(3) non-profit and be located within the boundaries of Calhoun County or provide services to residents of Calhoun County (if located outside of the County). Each non-profit partner agency must provide a financial audit and submit in-depth documentation of program funding. A group of local volunteers, the Allocations Committee, reviews all applications, meets with organization leadership, and determines allocation amounts divided between selected organizations, totaling the amount approved by the Board of Directors each year. Upon recommendation of the Allocations Committee to the Board of Directors, grants are selected and approved.

How does the United Way of Calhoun County operate with ethics & accountability?

The United Way of Calhoun County is committed to responsible stewardship of your gifts and transparency is how your gift is spent. Our monthly financial statements are reviewed by the Board of Directors, Treasurer and executive committee. Conducting our activities with honesty, integrity, and in the best interests of this organization is essential to preserving and continuing to grow our United Way here in Calhoun County. We have established and operate under a Code of Ethics and provide all of our financial documentation to the public on our website.
